

## EQUALITY & DIVERSITY POLICY

**Policy approved and adopted at the meeting of the Parish Council held on 6th September 2023**

### 1. Aims

The aim of this policy is to communicate the commitment of Catfield Parish Council, its Members and Officers to meeting the Public Sector Equality Duty, which came into force on 5 April 2011. The Equality Duty applies to public bodies and others carrying out public functions. It supports good decision-making by ensuring public bodies consider how different people will be affected by their activities, helping them to deliver policies, representation and services, which are efficient and effective; accessible to all; and which meet different people's needs.

### 2. Policy Statement

It is Catfield Parish Council's policy to provide representation, information, facilities, services and employment to all irrespective of:

- a. Gender, including gender reassignment
- b. Marital or civil partnership status
- c. Religious belief or political opinion
- d. Race (including colour, nationality, ethnic or national origins)
- e. Disability
- f. Sexual orientation
- g. Age

Catfield Parish Council is opposed to all forms of unlawful and unfair discrimination. All people and employees will be treated fairly and will not be discriminated against on any of the above grounds. All decisions will be made objectively and without unlawful discrimination.

Catfield Parish Council recognises that supporting Equality is of primary importance. This policy will help Councillors and Employees of the Council to develop sound and effective policies that impact on the village, community and surrounding areas.

Catfield Parish Council aims to create a culture that respects and values each other's differences, that promotes dignity, equality and diversity. We aim to remove barriers, bias or discrimination that prevent individuals or groups from realizing their potential and contributing fully to the community to develop a culture that positively values diversity.

Catfield Parish Council will challenge discrimination. It aims to provide equality and fairness to all in the community and expects all Members and Officers to be aware and understand the Equality Act 2010.

### 3. Equality Commitments

Catfield Parish Council is committed to:

- a) Promoting equality of opportunity for all persons
- b) Promoting a good and harmonious environment in which all persons are treated with respect.
- c) Preventing occurrences of unlawful direct discrimination, indirect discrimination, harassment and victimization
- d) Fulfilling our legal obligations under equality legislation and associated codes of practice.
- e) Complying with our own equal opportunities policy and associated policies.
- f) Taking lawful affirmative and positive action where appropriate

### 4. How we will implement this policy:

- a) Communicate the policy to all Councillors, Officers and members of the public
- b) Incorporate equal opportunities into general practices
- c) Ensure that other persons or organisations will comply with the policy in their dealings with the council

### 5. Monitoring and Review

The effectiveness of our equal opportunities policy will be reviewed annually, and action taken as necessary.

In addition to the Council's internal procedures, any person has the right to pursue complaints of discrimination under the Equality Act 2010.
